TENANT EXPECTATIONS:

- All dogs and cats must be registered with the city and LSV office. Visiting dogs are not allowed unless they have gone through the LSV registration process.
- Patios should be cleared off in preparation of snow.
- Toys left out on property will be picked up by maintenance and held for only 30 days.
- Back and front patios must be shoveled and remain clear of snow this winter.

REFERRALS APPRECIATED:

If you have friends or family that need a 3 bedroom, please refer them to our office. All applicants will need to have original birth certificates, social security cards and picture ID's for all household members. They will also need either rental history from the immediate past 5 years, 2 previous landlords in the immediate past 5 years or 3 letters of professional reference with an explanation of their living situation for the immediate past 5 years.
