a. Executive Director's Report

Executive Director:

Community Housing Network (CHN) reapplied to receive the 9% LIHTC award for two properties in Ishpeming. MHC is working with Port Huron Housing Commission to obtain some of their Fair Cloth units. These units will be converted into Project Based Vouchers through a RAD conversion. MHC will include these units in their HCV portfolio.

The MI Neighborhood grant was not funded as it was not reviewed as a municipal applicant. MSHDA has encouraged MHC to reapply so it can be placed in the right category. There is still money available in this category and hopefully the grant will be funded.

Four staff members (Heidi, Emily, Sarah, and Jacini) presented at the regional NAHRO conference. They presented on changes and challenges front line face during a RAD conversion.

I was elected as the Region 1 Vice-President for Michigan NAHRO. I have also requested to be considered for a seat on the National Professional Development Committee.

- **b. Youth and Family Center Report**: As presented in board packet. After the report was submitted, they also had an egg and basket hunt along with an Easter dinner. All the board members enjoy reading about all the activities.
- c. Financials: Question asked why Other Sundry went up so much. Answer is that it is a back payment for Michigan taxes in 2023 for the 4<sup>th</sup> quarter. Another question asked why payroll was so high for January. It was due to a 3-payroll month. Question asked why the telephone expense was so much higher than the previous month. The January check was not received so an EFT was done to cover the check. A credit was applied the following month. The properties are running well. Question asked what the Reserve for Replacement is set at. Commissioner asked if we had a Capital Reserve Study done. We had it done before the RAD conversion. They also listed which items would need to be replaced and when.
- **d.** Approval of checks: Kanso check questioned. It's cloud-based software. Check for running boards on the truck questioned. It's a safety item. Wondering if HCV rent checks will increase with fair market rents. Commissioner asked what HAP acronym stood for...Housing Assistance Payment.
- **e. Cash Positions Statement**: Money market pulled. One less account. Next month need to discuss what to do when the CD matures.
- **f. Pine Ridge**: Curious to know what will happen with the waitlist when the new 51 1-bedroom construction is completed.
- g. Lake Superior Village Report: A couple people owe money. We need to write it off in the motion.
- **h.** Housing Choice Voucher Report: We have PHA and HUD reserve money. In May the program may be increasing a good amount.

Motion made by Schumacher, seconded by Agassi, to approve the consent agenda, with the approval to write off the \$7,011.43 amount due to Lake Superior Village.
